

AMENDED SUB-AWARD AGREEMENT

This amended Agreement is entered into by and between the Puget Sound Clean Air Agency (hereinafter referred to as the "Agency"), a municipal corporation of the laws of the State of Washington, and Snohomish School District (hereinafter referred to as the "School District"), 4605 Bickford Ave, Snohomish, WA 98290.

WHEREAS, the Board of Directors of the Puget Sound Clean Air Agency deems it desirable to amend the original Agreement No. 2020-014-0, dated August 18, 2019, to increase the number of buses replaced by the School District; and

WHEREAS, the U.S. Environmental Protection Agency (EPA) awarded the Agency a Diesel Emission Reduction Act (DERA) Grant {Grant No. DE-01J53801-0 "Puget Sound School Bus Replacements (Diesel to Propane)" (CDFA 66.039)} on March 7, 2019; and

WHEREAS, the School District has an additional eligible diesel-fueled school bus that it intends to replace with a propane-fueled bus, bringing the total number of buses to be replaced under this School Bus Replacement Project to three; and

WHEREAS, the School District represents and warrants that it is available, experienced, and qualified to perform said amended services; and

NOW, THEREFORE, the Agency and the School District mutually agree as follows:

A. Agreement No. 2020-014-0 is amended as follows:

1. In Section 2, **School District's Responsibilities**, the contents of "Task 4: Purchase, insure, and deploy new school buses," is replaced with the following:

After tasks 1-3 have been completed and the Agency has approved the bus-scraping plan, the School District may proceed with purchasing new propane school buses. The School District will pay all costs associated with the purchase of the new school buses. The School district must insure the new school buses using the same insurance procedures and it does of all of its other school buses. The School District must deploy the new school buses by March 30, 2021.

Deliverables for Task 4.a:

Purchase and insure the new school buses by February 28, 2021

Deliverables for Task 4.b:

Deploy new school buses by March 30, 2021

2. In Section 2, **School District's Responsibilities**, the deliverable for "Task 7: Submit documentation for reimbursement" is replaced with:

Submit reimbursement documentation to the Agency within 60 days after deploying the school buses, but no later than March 30, 2021.

3. The first sentence of **Section 5, Compensation**, is replaced with the following sentence:

The total amount paid by the Agency for satisfactory performance of the work under this agreement will not exceed one hundred twelve thousand, five hundred dollars, \$112,500.

4. The last sentence of **Section 6, Term**, is replaced with the following sentence:

The termination date of this Agreement is June 30, 2021.

- B. All other terms and conditions of original Agreement No. 2020-014-0 remain in full force and effect.**




