### **SECTION C. TYPE OF PERMIT MODIFICATION (check only one)**

#### **Significant Permit Modification**

- The criteria for significant modifications are in [WAC 173-401-725\(4\)\(a\)](#). Every significant change in existing monitoring permit terms or conditions and every relaxation of reporting or recordkeeping permit terms or conditions shall be considered significant. Nothing herein shall be construed to preclude the permittee from making changes consistent with this chapter that would render existing permit compliance terms and conditions irrelevant.
- Significant permit modifications shall meet all requirements of this [WAC 173-401](#), including those for applications, public participation, review by affected states, and review by EPA, as they apply to permit issuance and permit renewal. Attach the information required in [WAC 173-401-510](#).

#### **Minor Permit Modification**

- Must meet the criteria in [WAC 173-401-725\(2\)\(a\)](#).
- Attach the information required in [WAC 173-401-725\(2\)\(b\)](#).

*Source's ability to make change: In accordance with [WAC 173-401-725\(f\)](#), the source may make the change proposed in its minor permit modification application immediately after it files such application provided that those changes requiring the submissions of a notice of construction application have been reviewed and approved by the permitting authority. After the source makes the change allowed by the preceding sentence, and until the permitting authority takes any of the actions specified in [WAC 173-401-725\(d\)](#), the source must comply with both the applicable requirements governing the change and the proposed permit terms and conditions. During this time period, the source need not comply with the existing permit terms and conditions it seeks to modify. However, if the source fails to comply with its proposed permit terms and conditions during this time period, the existing permit terms and conditions it seeks to modify may be enforced against it.*

*The permit shield under [WAC 173-401-640](#) does not extend to minor permit modifications.*

#### **Group processing of minor permit modifications**

- Group processing of modification may be used only for those permit modifications that meet the criteria in [WAC 173-401-725\(3\)\(a\)](#).
- Attach the information required in [WAC 173-401-725\(3\)\(b\)](#).

*The source's ability to make change is the same as minor permit modifications. The permit shield under [WAC 173-401-640](#) does not extend to minor permit modifications eligible for group processing.*
